Terms and conditions:

1. The Client who signifies his acceptance of this booking does so on behalf of himself and the other persons listed on this booking form, which means that all are bound by the booking conditions as if they had individually made the application themselves. Only Africa Geographic Travel and/or any Africa Geographic group company (AGT) has the authority to vary the terms and conditions as per this Booking Form and other communications between the Client and an AGT employee.
2. A 40% deposit is required to confirm the booking, of which half (20%) relates to incurred costs related to this booking and is non-refundable unless the expedition is cancelled by AGT or the Client cannot be accommodated on the expedition due to the expedition being full. The other half (20%) is refundable if the Client cancels his booking sooner than 8 weeks prior to the departure date.
3. The balance of the full amount due by the Client to AGT shall be payable not less than 8 weeks prior to the date of departure. If the full amount is not paid in due time, AGT reserves the right to treat the booking as cancelled by the Client. Bookings made within 8 weeks of the departure date must be paid in full immediately.
4. Should the Client amend his booking at any stage before 8 weeks prior to departure, AGT reserves the right to charge an amendment fee of USD 50 per person. No changes will be accepted sooner than 8 weeks prior to departure.
5. Should the Client fail to join an expedition, or fail to use the accommodation/services booked by AGT on their behalf for any reason whatsoever, they do so on their own risk and AGT will not be liable for any refund, credit or liability.
6. AGT acts as an agent for the establishments and service providers (the Parties) making up each expedition and accepts no liability for any loss or damage which the Client may suffer as a result of the failure of such Parties to fulfil their obligations, whether in relation to travel arrangements, accommodation, flights or otherwise.
7. AGT reserves the right to and shall be entitled to cancel any expedition prior to departure and in such case AGT shall be obligated to refund all amounts received from the Client, who shall have no further claim of whatsoever nature against AGT arising out of such cancellation.
8. Cancellation insurance is compulsory for all AGT bookings, and it is the Client's responsibility to arrange such insurance. AGT strongly recommends that the Client also take out personal and baggage insurance.
9. The Client acknowledges that the expedition itinerary and prices may be varied by AGT from time to time, if such changes are necessitated by third party factors, provided that the updated itinerary is not substantially different from the prior itinerary, and the Client shall not be entitled to cancel the booking as a result.
10. The Client acknowledges that he/she has the required valid travel and health documents, including but not limited to passport, visa and vaccination certificates. The Client also undertakes to research and equip themselves with all necessary medical and health treatments and medications. AGT will endeavour to assist the client in these regards but such assistance will be at AGT discretion, and this assistance will not imply the assumption by AGT of any Client obligations or liabilities in this regard.
11. The client acknowledges that the expedition may involve exposure to risks and danger, including but not limited to, transportation by road, off-road, air and boat, wild animals and the like, and the client voluntarily accepts all risk and responsibility in this regard. The client (which shall be deemed to include his/her heirs, executors, administrators or assigns) hereby irrevocably waives and abandons all and whatsoever rights and/or claims which he/she may have against AGT, any of its directors, employees, officers or agents, in consequence of death, injury or any loss or damage by whatsoever nature and howsoever arising which may be sustained directly or indirectly by the client and/or any of his/her dependants. The aforesaid waiver and abandonment shall be applicable regardless of whether such death, injury, loss or damages caused through any negligence, including gross negligence or recklessness, whether by act or omission of AGT or any of its directors, employees, officers or agents. Without derogating from the generality of the foregoing, the client hereby indemnifies and holds harmless AGT, its directors, employees, officers or agents, from all and any claims of whatsoever nature which may be brought by or on behalf of the client or any of his/her dependants. Nothing herein contained shall be construed as protecting AGT from the consequences of its own wilful intent.
12. These terms constitute the entire terms of the relationship between AGT and the Client. There exist no other terms and conditions and no amendment cancellation or waiver of any term or right referred to herein shall be valid or binding unless reduced to writing and signed by both parties.

The Client acknowledges that save and except for what has been stated herein, there exist no AGT warranties, representations, guarantees, promises, undertaking or inducements of any nature whatsoever. Any matter or things said or purportedly said by any person on behalf of AGT, irrespective as to the position such person occupies, and which is not stated herein, shall not be binding on AGT, irrespective as to the nature and extent of any such things, and the Client acknowledges that he/she has not relied on any matter or thing stated on behalf of AGT that is not included herein.
